
WHEREAS, Sh. Hari Singh, Animal Husbandry Assistant, Veterinary Hospital Goshal, Distt. Lahaul & Spiti, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 1926 of 2023 regarding his transfer from tribal area to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 12-04-2023 with the observations as under:-

“That writ in the nature of mandamus may very kindly be issued by directing the respondents to transfer the petitioner from present place of posting to his choice of stations as mentioned in ground E of writ petition i.e. (i) Veterinary Hospital Sainj, District Kullu (ii) Veterinary Hospital Gusheni, District Kullu, (iii) Veterinary Hospital Bhuntar, District Kullu (iv) Veterinary Hospital Bali Chowki, District Mandi (v) Veterinary Hospital Takoli, District Mandi and further direction may kindly be given to the respondents for transferring the petitioner in any other station(s) near to his native place against vacant post as well as against longer stay, within a time bound period, without imposing the condition of reliever.

THEREFORE, keeping in view the judgment/ orders passed by the Hon'ble High Court of Himachal Pradesh, his representation dated 06-03-2023 has been considered sympathetically by the undersigned and the petitioner is hereby ordered to be transferred and posted at Veterinary Hospital Sainj, Distt. Kullu vice Sh. Puran Chand, Animal Husbandry Assistant.
