
WHEREAS, Sh. Geeta Ram Negi, Animal Husbandry Assistant posted at Veterinary Hospital Katgaon, Distt. Kinnaur, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 7624 of 2023, regarding his transfer from tribal to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 11.10.2023 with the observations as under:-

“The petitioner is that despite completion of his tenure in the tribal area, respondents No. 2 and 3 have not considered his repeated representations for being posted at the station of his choice. Learned counsel for the petitioner submits that petitioner may be permitted to submit a fresh representation to respondent No. 2 as the previous representations of the petitioner are not strictly in terms of the Transfer Policy. He further submitted that the petitioner will be content in case respondent No. 2 is directed to consider and decide the representation of the petitioner in a time bound manner. 4. Prayer being innocuous is not opposed. 5. Accordingly, the petition is disposed of by permitting the petitioner to file a fresh representation within one week from today. On receipt of such representation, respondent No. 2 shall decide the same by passing a speaking and reasoned order within two weeks thereafter”.

THEREFORE, keeping in view the judgment/ orders passed by the Hon'ble High Court of Himachal Pradesh, his representation has been considered sympathetically by the undersigned and the petitioner is hereby ordered to be transferred and posted at Veterinary Hospital Dutt Nagar (Shimla) vice Sh. Santosh Kumar, Animal Husbandry Assistant.


