**OFFICE ORDER**

**WHEREAS**, Sh. Manoj Kumar, Veterinary Pharmacist, posted at Veterinary Hospital Koksar, Distt. Lahaul & Spiti, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No.1533/2024, regarding his transfer from tribal area to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 13.03.2024 with the observations as under:-

“The petitioner has prayed for following relief:-

That Respondent no.2 may kindly be directed to transfer the petitioner from present place of posting in compliance to clause 16 of the transfer policy without substitute against on following choice of stations.

- i. Veterinary Dispensary Salwana, Tehsil Sundernagar, Distt. Mandi, HP
- ii. Veterinray Dispensary Sohar, Tehsil Sundernagar, District Mandi, H.P.
- iii. Veterinary Dispensary Taleli, Tehsil Sundernagar, District Mandi, H.P.
- iv. Veterinary Dispensary Trifalghat, Tehsil Sundernagar, District Mandi, H.P.
- v. Veterinary Hospital Dehar, Tehsil Sundernagar, District Mandi, H.P.
- vi. Veterinary Dispensary Malyawar, Tehsil Ghumarwin, District Bilaspur, H.P.

Learned counsel for the petitioner has submitted that despite the fact that the petitioner has completed his normal tenure in a tribal area he is not being transferred out of that area though has already given a representation to the Competent Authority reflecting therein the stations which are vacant. Learned Advocate General submits that the representation of the petitioner. If not already decided, shall be decided by the Competent Authority within a period of four weeks from today. Statement of learned Advocate General is taken record. As agreed, the petition is disposed of by ordering that let the representation of the petitioner(Annexure P-I) be decided by the Competent Authority within a period of four weeks from today and if possible the petitioner be posted at the station of his choice in case any such station is vacant.

**WHEREAS**, the applicant has made a representation to the undersigned and requested to transfer him to one of the stations mentioned above.




