OFFICE ORDER

WHEREAS, Sh. Virender Kumar, Veterinary Pharmacist posted at Veterinary Dispensary Dhurith (Bharmour) Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 3352 of 2023, regarding his transfer from tribal to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 30.05.2023 with the observations as under:-

"That his representation dated 20.03.2023, seeking his transfer in terms of the policy, to the station of his choice after serving in a hard/tribal area, has not been decided till date. Learned counsel for the petitioner has submitted that petitioner shall be satisfied in case he is permitted to file a fresh representation to respondent No.2/ Director of Animal Husbandry, within three days and the same is decided in a time bound manner. Learned Additional Advocate General submits that in case such representation is preferred by the petitioner, same shall be decided in accordance with law, as expeditiously as possible, preferably within three weeks. In view of above, petitioner is permitted and directed to submit a fresh representation to respondent No.2/ Director of Animal Husbandry and in case, such representation is preferred on or before 06.06.2023, the same shall be decided by respondent No.2, on or before 30.06.2023, by passing an appropriate speaking and reasoned order in accordance with Rules, Policy and Law, as applicable. Needless to say that order shall be passed after giving the personal hearing to the petitioner, if desired so. Till the decision of representation, in case stations mentioned in the representation are lying vacant, at least one of such stations, shall be kept vacant, if not already filled.

THEREFORE, keeping in view the judgment/ orders passed by the Hon'ble High Court of Himachal Pradesh, his representation dated 31.05.2023 has been considered sympathetically by the undersigned and the petitioner is hereby ordered to be transferred and posted at Veterinary Dispensary Luddu (Chamba) vice Sh. Om Parkash, Veterinary Pharmacist.



OFFICE ORDER

WHEREAS, Sh. Ramesh Kumar, Veterinary Pharmacist is under transfer from Veterinary Dispensary Masroond (Chamba) to Veterinary Dispensary Karhoti (Pangi) Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 2758 of 2023, which was decided by the Hon'ble High Court of Himachal Pradesh on 12.05.2023 with the observations as under:-

“the petitioner is that vide order dated 03.02.2023, he has been transferred from Veterinary Dispensary Masroond, District Chamba to Veterinary Dispensary Karhoti, Teshil Pangi, District Chamba, whereas, his wife is serving as JBT in Government Primary School Kakrita (Masroond), District Chamba and petitioner has already served in tribal area for a period of six years and he has been transferred to a place situated in tribal at a distance of about 200 kilometers, despite the fact that posts are laying vacant at Veterinary Dispensary Siula, Tehsil Salooni, District Chamba. Learned counsel for the petitioner submits that petitioner shall be satisfied in case he is permitted to file a detailed representation to respondent No.2, with further direction to respondent No.2 to consider and decide the same in a time bound manner. Considering the aforesaid facts and circumstances, petitioner is permitted and directed to submit a detailed representation for redresal of his grievances on or before 16.05.2023, to respondent No.2-Director, Animal Husbandry Department, and in case, such representation is preferred, the same shall be decided by respondent No.2 on or before 30.05.2023, by passing an appropriate speaking and reasoned order in accordance with Rules, Policy and law as applicable. . Needless to say that order shall be passed after giving the personal hearing to petitioner, if desired so. Till the decision of representation, petitioner shall not be compelled to join at next place of posting and he may apply for leave of kind due”.

THEREFORE, keeping in view the judgment/ orders passed by the Hon'ble High Court of Himachal Pradesh, his representation dated 29.05.2023 has been considered sympathetically by the undersigned and the petitioner is hereby adjusted at Veterinary Dispensary Gwalu (Chamba) vice Smt. Surekha Devi, Veterinary Pharmacist.




