Submission of Bids: Bids shall be submitted in sealed super scribed as "Tender for disposal of store articles (General Articles)". The bidder shall submit an EMD along with Bid in the form of Demand draft amounting to Rs.5000/- (Rupees Five Thousand Only) drawn in favor of Director, Directorate of Animal Husbandry Boileauganj , Shimla-5, failing which the bid will be summarily rejected. EMD in any form other than stated above shall not be accepted.

GENERAL TERMS & CONDITIONS OF TENDER:-


1. Bidders may inspect the items on the stipulated date and time.
2. The items shall be sold to the highest bidder.
3. The Earnest Money Deposit (EMD) of successful bidder shall be returned after full payment of the bid.
4. The successful bidder has to make full payment immediately after completion of auction process failing which the offer will be cancelled and EMD shall stand forfeited. If the highest quoting firm/bidder fails to honor the bid, the bid will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible bidder to complete the bid provided it is prepared to accept the price offered by the first party. In case of any dispute, decision of the Director, Directorate of Animal Husbandry Boileauganj , Shimla-5 shall be final. The EMD of unsuccessful bidders shall be returned.
5. Item once disposed off to the successful bidder shall not be taken back by this Department on any condition, whatsoever.
6. The successful bidder(s) will be required to lift all the items from the disposal site within 24 hours after the payment of full payment. On failure to do so, this Department shall have right to forfeit the entire amount of the bidder and dispose off the items to alternate bidder. The successful bidder will be required to make their own arrangement of transport, labour etc. for lifting the items, on their own cost.
