**Terms and conditions of appointment of members of the Board**

1. Every non-official member of the Board shall hold office for a period of three years in State from the date on which the appointment is notified in the Gazette.
2. The non-official member shall be paid such allowances as may be prescribed.
3. A non-official member may resign the office in writing under his hand and addressed to the Government.
4. The Government shall remove a person from the office of non-official member by giving a reasonable opportunity of being heard in the matter if he/she:-
  - a. becomes an undercharged insolvent.
  - b. is convicted and sentenced to imprisonment for an offence, which, in the opinion of the State Government, involves moral turpitude;
  - c. becomes of unsound mind and stands so declared by a competent Court;



- d. refuses to act or becomes incapable of acting;
- e. is absent, without obtaining leave of absence from the Board, from three consecutive meetings of the Board or has, in the opinion of the State Government abused the position of Chairman or Member.

**Disqualifications:-**

No person shall be eligible for appointment as a non-official member if he/she:

- a. is not a citizen of India;
- b. has not attained the age of twenty one years.
- c. has been adjudged by a Competent Court to be of unsound mind;
- d. has been sentenced by any court to imprisonment for an offence involving moral turpitude;
- e. has been dismissed from the service of the Government for misconduct and has been declared to be disqualified for employment in public services; and
- f. is an undischarged insolvent.


