
**WHEREAS,** Sh. Devinder Kumar, Veterinary Pharmacist, Veterinary Dispensary Garola, Tehsil Bharmour, Distt. Chamba, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 2923 of 2023 regarding his transfer to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 18-05-2023 with the observations as under:-

“The petitioner submits that the petitioner shall be satisfied in case a time bound direction is given to the respondents, particularly, Director of Animal Husbandry Department/respondent No.2, to decide his representation dated 29.4.2023 (Annexure P-2) forwarded to the Director, through proper channel, as the petitioner has completed his normal tenure in the hard area and in terms of transfer policy, he is entitled to be posted at one of the stations, out of five stations of choice. Considering the submissions made on behalf of the petitioner, Director of Animal Husbandry-responent No.2 is directed to decide representation of the petitioner on or before 31.05.2023, by passing a appropriate speaking and reasoned order in accordance with Rules, Policy and law as applicable. Needless to say that order shall be passed after giving personal hearing to petitioner, if desired so, and in case stations, mentioned in the representation, are lying vacant, the same shall not be filled till the decision of the representation, if not already filled”.

**THEREFORE,** keeping in view the judgment/ orders passed by the Hon'ble High Court of Himachal Pradesh, his representation dated 13-05-2023 has been considered sympathetically by the undersigned and the petitioner is hereby ordered to be transferred and posted at Veterinary Dispensary Udaipur (Chamba) vice Sh. Atul Chona, Veterinary Pharmacist.






