OFFICE ORDER

WHEREAS, Sh. Pawan Kumar, Veterinary Pharmacist posted at Veterinary Dispensary Gareema (Bharmour), Distt. Chamba, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 6066 of 2023, regarding his transfer from tribal to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 04.09.2023 with the observations as under:-

"The petitioner is presently serving as Veterinary Pharmacist, in Veterinary Dispensary Gareema, tehsil Bharmaour, District Chamba, H.P., stated to be a hard/tribal area. He is stated to have completed the obligatory period of two winters and three summers as per the government policy at the present place of posting. Grievance of the petitioner is that his representation dated 26.05.2023 (Annexure P-3), seeking transfer from the present place of posting to a soft station, is not being considered by the competent authority in accordance with law. Learned counsel for the petitioner submits that the petitioner would be content in case directions are issued to the respondents/competent authority to decide the aforesaid representation within a fixed time schedule. 4. In view of the above submissions, this writ petition is disposed of by directing the respondents/ competent authority to decide the representation of the petitioner dated 26.05.2023 (Annexure P-3) within three weeks from today in accordance with law and applicable policy. The decision so arrived at shall be communicated to the petitioner"

THEREFORE, keeping in view the judgment/ orders passed by the Hon'ble High Court of Himachal Pradesh, his representation dated 26.05.2023 has been considered sympathetically by the undersigned and the petitioner is hereby ordered to be transferred and posted at Sub Division Veterinary Hospital Nurpur (Kangra) vice Sh. Narender, Veterinary Pharmacist.
