OFFICE ORDER


WHEREAS, Sh. Sita Ram, Animal Husbandry Assistant U/t from VH Kunihar (Solan) to VH Patta Mehlog (Solan) Distt. Solan, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 857 of 2023, which was decided by the Hon'ble High Court of Himachal Pradesh on 29.08.2023 with the observations as under:-

“The petitioner has laid challenge to the office order dated 28.02.2023 whereunder, he, a Veterinary Inspector, has been transferred from Veterinary Hospital Kunihar (Solan) to Veterinary Hospital Mehlog (Solan). Pursuant to the interim order dated 06.03.2023, the petitioner is continuing at Veterinary Hospital Kunihar (Solan). The respondents have filed reply to the writ petition giving incumbency position of the petitioner. Reply further states that the petitioner out of his 10 postings has remained posted 7 times on his own request at the places of his choice. The incumbency position reflected in the reply prima facie indicates that the petitioner has remained posted at the places of his choice. These facts have not been disputed by learned counsel for the petitioner. In view of above, learned counsel for the petitioner submits that he is under instructions to withdraw the present writ petition as the petitioner intends to represent to the respondent-department seeking his adjustment in view of petitioner's impending retirement on 31.05.2024.”

THEREFORE, the representation dated 01.09.2023 and 25.09.23 submitted by Sh. Sita Ram, Animal Husbandry Assistant has been considered and rejected due to non availability of vacancy. The previous transfer order No. AHY-H(1)B(4)-172/81-132-L dated 28.02.2023 shall be effective.
