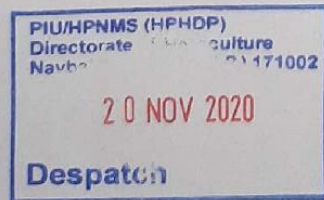

3. The candidate will be paid remuneration of Rs 50,000/- per month and TDS will apply accordingly.
4. Candidate can be placed anywhere in Himachal Pradesh during the contract period and can be Shifted/posted in any other place in the interest of the Project.
5. Candidate is required to submit "Medical-fitness Certificate" issued by Chief Medical Officer of concerned District in HP.
