The appointment shall be on contract basis initially for a period of one year from the date of joining the post, the contract can be reviewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without any notice.

1. The Horticulture Extension Officer appointed on contract basis will be paid consolidated monthly emoluments equivalent to the minimum of the pay band of Rs. 5910-20200+2400 Grade Pay + 125% G.P (Rs. 5910+2400(G.P)+3000/-).
2. The services of the contractual Horticulture Extension Officer will be purely on temporary basis. The appointment is liable to be terminated in case the performance/ conduct of the contract appointee is not found good.
3. Contractual appointment shall not confer any right to the incumbent for the regularization in service at any stage.
4. As per Terms & conditions amended vide letter No PER(AP)-C-B(2)-2/2015, dated 22<sup>nd</sup> April, 2016 Contractual Horticulture Extension Officer will be entitled for one day casual leave after putting one month service. However, the contract employee will also be entitled for 180 days maternity leave, 10 days medical leave and 5 days special leave. A female contract appointee shall also be entitled for maternity leave not exceeding 45 days (irrespective of the number of surviving children) during the entire service. He/ She will not be entitled for Medical Reimbursement and L.T.C. etc. No leave of any other kind except above is admissible to them, Provided that the un-availed Casual Leave, Medical Leave and Special Leave can be accumulated up to the calendar year and will not be carried forward for the next calendar year.
5. Unauthorized absence from the service without the approval of the Head of the Office shall automatically lead to the termination of the contract. Contractual Horticulture Extension Officers will not be entitled for any contractual amount for the period of absence from duty.

6. Contractual Horticulture Extension Officers who will have completed three years tenure at one place of posting will be eligible for transfer. The transfer on administrative grounds, where ever required, will be made on need based basis and against vacant or contract employee only.
7. Certificate of the Medical Fitness issued by the Chief Medical Officer of concerned District in Himachal Pradesh.
8. After selection of a candidate, He/She has to sign an agreement as per annexure-"A" appended to these rules.
9. Contractual Horticulture Extension Officers shall be entitled to TA/DA if required to go on tour in connection with official duties at the same rate as applicable to regular Horticulture Extension Officers.
10. No TA/DA will be admissible for joining this assignment.
11. If above terms and conditions acceptable to the concerned Horticulture Extension Officer, they may join their duty on or before 15.12.2019 failing which the appointment offer shall automatically stand cancelled.
